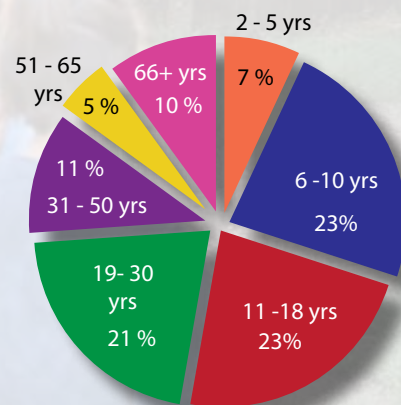

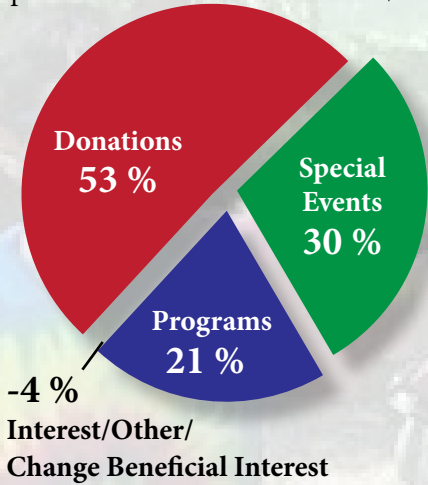
Ages of our Participants



Financial Review

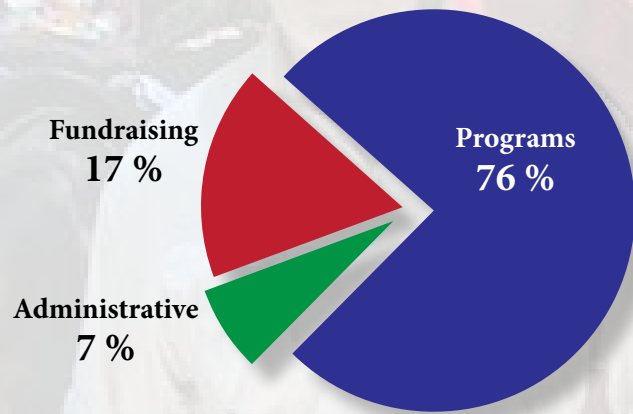
2022 Income \$520,909
